THE CAPITAL OF RUSSIA: MOSCOW THE BUSINESSCENTRE MOSCOW CITY



• Russia is a modern country with a lot of similar challenges as the EU.

- Moscow city business center (photo below) Comparable with the ZuidAs in Amsterdam and the City in London.

FACTS AND FIGURES I

- Capital Moscow, more than 12 million inhabitants (year: 2016) and daily even more than 5 million visitors. This means: the biggest city in Russia, also bigger than any city in the EU and than New York.
- RUSSIA: 146 million inhabitants (year 2014), more than 17 million KM2 of which 45 % forest, (more than 457 x The Netherlands). Approximately 61.000 KM frontiers, (of which approximately 39.000 KM waterfrontiers). 1/9 of planet earth (not counting rivers and seas). 11 timezones. 81 % of the people have the Russian nationality.
- Russia has 46 provinces (областей) with their own local government, and extra to that: 22 republics (республик) and 9 area's (крайев), 4 autonomous area's (автономных округа) en 1 autonomous province (автономная област Rechta)

FACTS AND FIGURES II

- Official language: Russian. 150 languages spoken in the country. English spoken in the cities and among higher educated people.
- Per person more than 400 kilo garbidge per year (several sources, like Greenpeace).
- In comparance with the Netherlands: approximately 500 kilo garbidge per person per year.
- 3,8 milljard ton garbidge total in Russia per year.

SOME FACTS ABOUT WASTE AND WASTE MANAGEMENT (pictures about how it was, or at some places still is)







CONCERNING FORMER SHEET

- Garbidge is not collected separately in Russia.
- Choice: landfills, burning or recycling. In Russia in most of the places untill now garbidge goes into landfills or is burned.
- Greepeace recently started a campaign to collect signatures in order to change the law that recycling will be mandatory and not voluntary.
- Only 5 % of the garbidge in Russia is recycled. In Western countries this percentage amounts to 70 % (source: Greenpeace).

- What is on the picture below?
 Pink = landfill.
 Logotype of factory: burning
 Logotype mountain:
 extension of existing landfill.
- In Moscow region currently there are no plans for separate collection of garbidge and recycling, reason for Greenpeace to set up a campaign.
- All regions of the Russian Federation have their own policy regarding waste management.

- Do's:
- Take a small present (Dutch souvenir, bottle of genever or whiskey)
- Take flowers (or chocolates) for the secretary.
- Drink a glass of vodka together
- Say a toast before starting to drink
- Say yes to the banja (Russian sauna)
- make a compliment.

- Don'ts:
- Avoid the 'in your country discussion'
- Avoid to stress the prejudices about Russia like bribery and alcoholism.
- Avoid political discussions: you will not change the political situation and it can spoil your business relation within one minute.
- Don't give your opinion about Crimea.



- KEEP IN MIND:
- Western mass media is not correctly informing you about Russia;
- Russian media is since the sanctions also very critical about the EU;
- Russians wants also to live a better life and they have children also.
- Russians traveled a lot abroad the last 25 years: they became globalists as well.
- Russians have also social media and like facebook.



- SOME WORDS ABOUT THE LEGAL SYSTEM:
 - Russia introduced a Civil Code in 1996 who is based upon the Dutch Civil Code.
 - Russia has a good working legal system, generally spoken. Only in huge cases or political cases there can happen something unexpected.

CONTRACTING WITH A RUSSIAN COMPANY:

 Recommandabele to put in the contract the phrase: in case of a dispute: the Dutch court will be compentent and Dutch law will be applicable. Keep in mind that you can give free consultancy if you don't sign a document at forehand such as a MOU or confidentiality agreement.
